This report is only for pre-1982 years served with Pension Claim upon the former Kentucky Annual Conference and the former Louisville Annual Conference and payments made for such years. The report does not include pension payments for service in other conferences or the service after 1981.

The annuity rates paid to Ministerial Claimants during 2007 were set by the Kentucky Annual Conference in June 2006 at \$577.50 per year of approved service in the former Kentucky Conference and at \$577.50 per year of approved service in the former Louisville Conference. In addition, a special grant of \$60 per service year was approved for former Louisville Conference retirees which is paid out of the former Louisville Annual Conference Deposit Account. Also shown below are Disability payment totals and Survivor Minimum Benefit payment totals from the Comprehensive Protection Plan.

## INDEPENDENT AUDITORS' REPORT

Board of Directors  
The Kentucky Conference of the United Methodist Church

We have audited the statement of assets and net assets - modified cash basis of the Kentucky Conference of the United Methodist Church as of December 31, 2007 and the related statement of cash receipts and disbursements and changes in net assets for the year then ended. These financial statements are the responsibility of the Conference's management. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with U.S. generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As described in the notes to financial statements, it is the policy of the Conference to prepare its financial statements on the modified cash basis; consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. As described in the notes to financial statements, the Conference has chosen not to obtain appraisals on buildings and equipment purchased prior to 1983 on which no cost records exist. These assets have been placed on the books by the Conference at an estimated cost, which may or may not approximate historical cost. It is also the policy of the Conference not to record depreciation expense for capitalized assets. U.S. generally accepted accounting principles require the inclusion of such expense. Accordingly, the accompanying financial statements are not intended to present financial position and results of operations in conformity with U.S. generally accepted accounting principles.

In our opinion, except for the effects of not recording cost appraisals and depreciation for capitalized assets, as discussed in the preceding paragraph, the financial statements referred to above present fairly, in all material respects, the assets and net assets - modified cash basis arising from cash transactions of the Kentucky Conference of the United Methodist Church as of December 31, 2007, and the cash receipts and disbursements and changes in net assets for the year then ended on the basis of accounting described in the notes to financial statements.

Our audit was conducted for the purpose of forming an opinion on the basic financial statements taken as a whole. The supplementary information on page 12 is presented for the purpose of additional analysis and is not a required part of the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and, in our opinion, is fairly stated in all material respects in relation to the basic financial statements taken as a whole.

**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

General

The Kentucky Conference of the United Methodist Church is a tax exempt, non-profit section 501(c)(3) organization under the Internal Revenue Code, principally on the cash receipts, cash disbursements method of accounting except for recording notes receivable, marketable securities and investments. The difference between the financial statements presented on that basis and those that would result from use of the accrual basis of accounting has not been determined.

The Kentucky Conference is the primary organization of the Church for supporting local churches and ministries.

Pension Deposit Account

This account consists of funds held by the General Board of Pensions of the United Methodist Church, designated for payment of benefits, and controlled by the Kentucky Conference of the United Methodist Church.

Investments

Investments are reported at fair value and unrealized gains and losses are allocated to individual funds annually. Stated fair value is as reported by various investment custodians.

**FUND ACCOUNTING**

The accounts of the Conference are maintained in accordance with the principles of fund accounting. Under fund accounting, resources for various purposes are classified for accounting and reporting purposes into funds established according to their nature and purpose. Separate accounts are maintained for each fund; however, in the accompanying financial statements, funds that have similar characteristics have been combined into fund groups.

Student loans are issued at 6% and can be repaid by serving five years as a minister in the Kentucky Conference after completion of formal education. The loans are prorated according to years of service.

Church extension loans bear interest at the rate of 6% per annum on the unpaid balance remaining at the end of five years until the outstanding balance is paid in full.

**LAND, BUILDING, AND EQUIPMENT**

The Conference follows the practice of capitalizing all expenditures for land, building, and equipment in excess of \$250, and the fair market value of donated assets is similarly capitalized. Depreciation is not recorded.

Prior to 1983, the Conference did not record the acquisition of assets. The fund was reconstructed from past records, current appraisals and the administration's estimates of the holdings of the organization.

If a local church ceases its operations, the title to the church property passes to the Conference. The properties and related mortgages are not recorded on the Conference books since no fair market value of the property is available and the administration has chosen not to obtain a current appraisal. The Conference directs the Trustees to dispose of the property, and proceeds are distributed as directed by the Conference.

**PENSION PLAN AND DEPOSITS WITH THE GENERAL BOARD OF PENSIONS**

Substantially all ministers of the Kentucky Conference are covered by a defined benefit multi-employer pension plan and/or a defined contribution plan administered by the General Board of Pensions of The United Methodist Church. Contributions to the plan are determined annually, within certain guidelines, by the Conference. Ministers and lay persons have been covered under the defined contribution Ministerial Pension Plan (MPP) or Cumulative Pension and Benefit Fund (CPBF) since January 1, 1982. These defined contribution plans are administered by the General Board of Pensions and Health Benefits of the United Methodist Church as "Church Plans" under Sections 414(e) and 403(b) of the Internal Revenue Code. Contributions for conference staff to the defined benefit plans for the year ended December 31, 2007 were \$271,381.

The Minister's Reserve Pension Fund (MRPF) is a defined benefit plan covering full-time service prior to 1982. The Kentucky Conference reflects a funding credit of \$66,477,406 as its share of unfunded vested benefits for the year ended December 31, 2007. Former Louisville Conference retirees and surviving spouses continue to receive special grants from the Pension Deposit Account based upon pre 1982 service.

**CONCENTRATION OF CREDIT RISK**

Financial instruments which potentially subject the Conference to concentrations of credit risk consist of cash and cash equivalents. The Conference places its funds with high credit quality financial institutions; however, cash balances from time-to-time exceed federally-insured limits.

**LEASES**

The Conference has entered into leases for office space in Lexington, Kentucky. The leases are generally for one year periods expiring December 31, 2007.

**CONFERENCE OFFICES**

During 2002 the Conference opened a new office facility in Crestwood, Kentucky. The offices are housed with a conference center, which was developed for the Kavanaugh Life Enrichment Center. Funding for the offices was completed through the issue of Cultural and Educational Development Revenue Bonds by the City of Crestwood, Kentucky. The bonds were sold through National City Bank - Kentucky and the proceeds were loaned to the Conference. The Conference's obligation was for an initial amount of \$1,400,000 payable in one hundred and twenty installments with a final payment of principal and interest due June 1, 2012. At December 31, 2007 the loan balance was \$1,266,968 with interest at 5.57%. Interest expense for the year ended December 31, 2007 was \$72,286.

**ESTIMATES**

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
